YOU HAVE **RIGHTS**

RESPECT

All members of the Leeward CC community will be treated with respect as the College seeks to provide appropriate, private, timely and fair responses to reports of sexual misconduct. Retaliation will not be tolerated.

REPORT

We strongly encourage everyone to report behavior that may be considered sex discrimination, gender-based violence or retaliation. All complaints, concerns or questions should be submitted to any of the college staff listed on the back of this card. Confidential assistance is also available and listed on the back of this card.

RESPOND

The College will respond to reports of sexual misconduct with support & resources and will proceed while honoring the rights of the students or employees impacted by the report. Community safety and wellness will be taken into account when confidentiality is requested and/or when a Reporting Party decides not to participate in the process.

REVIEW

All reports of sexual misconduct will be reviewed, and if deemed appropriate, investigated. A determination will be made whether it is "more likely than not" that a Responding Party engaged in sexual misconduct. Either party may appeal the decision.
