**Application Instructions** \*\*Applicants must be 18 years old OR have completed secondary school prior to enrollment

*The following forms and documents are required for admission to Leeward Community College (Leeward CC)*

**STEP 1**

Submit an [online application](#). If you are a first-time applicant, you will need to create an account before you can submit an application. This application is being used by all seven (7) University of Hawai‘i Community Colleges. From the “Add Program” section of the application, please be sure to select an academic major that is offered at “Leeward CC Main Campus – Pearl City, Oahu”. \*There is a non-refundable \$25 application fee.

B. Official or Unofficial Transcripts/Grade Report from high school or college/university. (If the last school you attended was a college or university, submit a copy of your transcript from <b>each</b> college and/or university attended.)	
C. <b>CREDIT PROGRAM APPLICANTS ONLY:</b> Official <a href="#">TOEFL</a> : 61 on iBT or 500 paper test / <a href="#">IELTS</a> : 5.5 / <a href="#">Step Eiken</a> : 2A / <a href="#">GTEC</a> : 1051 / <a href="#">duolingo</a> : 90 / <a href="#">Pearson Test for English Academic</a> : 45 / <a href="#">LanguageCert</a> International ESOL B2 Communicator: 33-50 <b>ESL Pathway Program Applicants may apply without an official English Proficiency Test Score.</b>	
D. * <a href="#">Affidavit of Support Form</a> AND <b>official bank statement</b> from financial sponsor verifying a minimum amount of US\$25,550 for one academic year. The Office of International Programs does not accept statements from investment accounts such as stocks, bonds, or life insurance, as proof of financial support.	
E. Copy of passport photo page	

\*Applicants who wish to bring their dependent (spouse and/or children) to the United States as F-2 visa holders must show proof of an additional US\$5,000 for the first dependent and US\$3,000 each thereafter.

Applicants who are currently in the U.S. must submit the following forms and documents.

F. Copy of U.S. Visa or Change of Status Approval Notice from USCIS. **	
G. Form I-94. (Please retrieve your I-94 from <a href="https://i94.cbp.dhs.gov/i94/#/home#section">https://i94.cbp.dhs.gov/i94/#/home#section</a> )**	
H. Copy of I-20 and <a href="#">Transfer Information Form</a> (ONLY for applicants who are on an F-1 student visa).	

\*\*If you are a dependent and have a primary visa holder, please submit a copy of your primary visa holder’s passport photo page, U.S. Visa, and the Form I-94.

Summer terms (Mid-May through early Aug)	March 1	April 15

Applications are accepted on a rolling basis; however, we strongly recommend applying 3 months before the start of a semester.
